



2019 Hsin-Yi Children's Animation Awards

Why We're Holding this Event

We aim to improve the quality of animations targeted at children and their ability to appreciate it. At the same time, we want to award talented people who contribute to animations around the world for providing a more diverse selection of good material for children.

The Prizes

International Division

Top prize (1) : US\$2,000 (approx. NT\$60,000) and award medal
Runner-up (1) : US\$1,000 (approx. NT\$30,000) and award medal
Special Mention: award medal

Taiwan Division

Top prize (1) : NT\$100,000 and award medal
Runner-up (1) : NT\$50,000 and award medal

What Can be Submitted

- Works must be age-appropriate animated videos for children aged 3 - 12
- The competition is open to any work published after July 15, 2017
- There are no nationality restrictions for International Division submissions
- Submissions to the Taiwan Division must have local Taiwanese creators to participate in the development.
- Submissions are open from March 1 to July 31, 2019

Criteria for Judging

- Preliminaries : Submissions are entered into the competition after being selected by a panel of preliminary judges.
- Finals : A second panel of judges selects top prize, runner-up and Special Mention winners.
- The judges may elect not to choose a recipient if no submissions match their criteria.
- Results will be publicized at an awards ceremony in November 2019. Winners' names will be published on the Hsin-Yi Foundation website and on the Hsin-Yi magazine.

Formats and Additional Information

- **Length** : Animations must be less than 30 minutes in length (including opening and closing credits)
- **Format** : MPG, MPG4, or AVI file format (1920x1080 NTSC)
- **Required** :
 1. Signed application form
 2. 3-5 still captures from video in JPEG format (300 dpi or above preferred)
 3. 1 photo of director in JPEG format (300 dpi or above preferred)
 4. English subtitles for any dialogue or narration that is not in either English or Chinese

Formats and Additional Information

- Participants who submit their works for the International or Taiwan Divisions must agree to provide their submissions to the event organizer free of charge for public screening as necessitated by the awards presentation and promotional activities. The event organizer reserves the right to use a 30-second clip from the submission for the sake of promoting this event.
- International Division submissions are not required to be making a premier at the event, and submissions to that division are welcome even if they have won awards previously.
- Taiwan Division submissions may not have been previously made public or released in any manner to any medium (with the exception of personal Facebook accounts, YouTube channels, or blogs).
- Hsin-Yi Foundation will own the exclusive publication rights for the top prize-winning work in the Taiwan Division. Hsin-Yi Foundation will possess priority rights of publication for the runner-up prize in that division. (These rules do not apply to International Division winners.)
